- Two drivers nominated by licensed drivers of the previous season

At the discretion of the Licence Committee, after consideration of the application form a Licence will be issued in return for the relevant licence fee, which shall entitle the licensed driver to participate in Rebels Races during that Year. The decision of the Licence committee may be by majority and that decision shall be final. **The committee can refuse without reason an application for a licence.**
